Instruction Sheet

**Introduction:** This Handout gives information about 4 year B. Tech. & 5 year MBA (Tech.) programmes for the SAT Exam qualified or 90% PCM candidate only.

1. **Program :**

**B.Tech**

➤ Specialization:

- For Mumbai Campus: Information Technology, Computer, Mechatronics, Mechanical, Civil , Electronics & Telecommunication Engineering, Electrical & Data Science
- For Shirpur Campus: Computer, Mechanical, Electronics & Telecommunication Engineering, Mechatronics & IT

**MBA Tech**

➤ Specialization:

- For Mumbai Campus: Information Technology, Computer, Chemical, Mechanical, Civil and Electronics & Telecommunication Engineering
- For Shirpur Campus Information Technology, Computer, Mechanical, Civil , Electrical and Electronics & Telecommunication Engineering
- For Navi Mumbai & Indore : Computer ,Mechanical

2. **Eligibility criteria**

Candidate must have passed 10 + 2 or equivalent examination from recognized board including International Baccalaureate Diploma (IB certificate or / & DP awarded are **not eligible**) with English as compulsory subject with science or science vocational,

Candidate must have secured 1200+ marks in SAT exam and / or Minimum 90% marks in PCM for Mumbai /Navi Mumbai/Indore / Shirpur campus

**or**

Candidate must have secured 1200+ marks in SAT exam & minimum 50% marks in PCM for Mumbai /Navi Mumbai/Indore campus & 45% marks in PCM for Shirpur campus Candidate with IB Diploma is eligible only if he/she has offered Mathematics at higher level (HL).

Candidates of CBSE, ICSE, should mention in online registration / e-admission form (if selected) 10th /10+2 or equivalent aggregate marks of all subjects for which candidate has taken & appeared for (not best of Four, Five, Six or seven). The candidates shall have passed all the subjects taken & appeared for in the applicable examination/s. The aggregate percentage of all subjects for which the candidate has taken & appeared will be taken into consideration & PCM % for confirming eligibility of the candidate for the program.

In case the mark sheet issued by the applicable Board/Institution is in percentile/s, the actual aggregate percentage of all the subjects appeared by the candidate will be taken into consideration.

Candidate above 25 years of age are not eligible to apply.

Note (for IB & Cambridge Candidate): Candidates called for admission counseling on the basis of NPAT merit list & who have not received final marksheet till then will be given Provisional Admission based on predicted score. Fees will be accepted from such candidates but their admission will be confirmed only on submission of final marksheet before the commencement of the program if found eligible.

Marksheet/Transcripts issued by Board/University only be considered (School/Institute will not be accepted)

Submission of AIU equivalence certificate to confirm the eligibility for the program is mandatory for those candidates who have completed their 10+2 or equivalent examination from overseas board/Universities

Candidates passing 10+2 or equivalent examination from Open or Distance learning (ODL) school recognized only by National Institute of Open schooling (NIOS) can apply for the program subject to fulfilling the eligibility of the program & candidates who have passed the 10+2 or equivalent examination by doing part-time course or through distance learning/correspondence/externally/open school other than NIOS are not eligible to apply for the courses.

Those candidates who have passed, or, are appearing for 10+2 examination from a Board/University where Grade Point Average is given, such candidates must produce in writing from the Board/University concerned, the equivalent percentage for the GPA /CGPA obtained.

Candidate whose final marksheet is not available at the time of admission is required to submit internet copy of result duly attested by Principal of the school/college, failing which candidate will not be admitted.

Only single marksheet with all compulsory subjects taken and passed in one attempt is mandatory, no compartmentalized marksheet will be considered.

Candidate will not be eligible if any subject is marked as ungraded / fail in the marksheet / grade sheet. For absent / Ungraded in any of the additional/non mandatory subject will be consider as eligible provided such candidates is declared as pass by respective board.

Candidates appearing for their final 10+2 or equivalent examination can also apply provided they obtain the required minimum cut off marks and also produce all the necessary documents, in original, within the given stipulated time.

3. **Duration: B.Tech 4 Yrs & MBA Tech 5 Yrs.**

4. **Admission Process:**

- Online registration & Payment of fees: Registration Online on website [www.nmims.edu](http://www.nmims.edu) & Pay fees of Rs.1000/- . (Please refer online registration for payment details.)

Selection Process:

- Merit list will be prepared on the basis of the performance of the candidate in SAT exam or PCM %
- First preference in merit will be for candidate with SAT (Min 1200) & PCM % (Min 90%), Second Preference in merit will be for candidate with SAT (Min 1200) only & Third preference in merit will be for candidate with PCM % (Min 90%)
- In the counseling session candidates will be given admission to various disciplines as per their merit, choice and availability of discipline as per eligibility criteria.
- The decision of the institute will be final in this regard and no inquiries or correspondence in this regard will be entertained

**Note:**

- Candidates are required to update 12<sup>th</sup> or equivalent exam or predicted marks in registration form.
- **Candidate will not be considered for merit list if they fail to update the same in online registration form.**
- It is the sole responsibility of the candidate to ensure that correct marks are entered.
- At any given point of time if it is found that the information given by candidate i.e 12<sup>th</sup> or equivalent exam /SAT Score is incorrect, the candidate admission will be cancelled and fees will be refunded as per refund rule

➤ **Merit Tie: Determination of merit in case of tie.**

1. 10+2 or equivalent exam PCM %
2. 10+2 or equivalent exam aggregate %
3. 10<sup>th</sup> or equivalent exam aggregate %

5. **Refund Rules:**

Candidate should submit a written request for withdrawal / cancellation of admission & submit it to NMIMS, Admission dept along with original fee receipt.

The Schedule of refund of fees will be as follows as per UGC rule Dec 2016:

If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution concerned shall follow the following four-tier system for the refund of fees remitted by the student.

Sr. No.	Percentage of Refund of Aggregate fees*	Point of time when notice of withdrawal of admission is served to HEI
(1)	100%	15 days before the formally-notified last date of admission (i.e on or before 16 <sup>th</sup> July 2018)
(2)	80%	Not more than 15 days after the formally-notified last date of admission(i.e from 17 <sup>th</sup> July 2018 to 16 <sup>th</sup> August 2018)
(3)	50%	More than 15 days but less than 30 days after formally-notified last date of admission (i.e 17 <sup>th</sup> August 2018 to 31 <sup>st</sup> August 2018)
(4)	00%	More than 30 days after formally-notified last date of admission (i.e from 1.9.2018 onwards)

In case of (1) in the table above, the deduction will be 10% of the aggregate fees as processing charges from the refundable amount. Aggregate fees is inclusive of course fees and non-tuition fees but exclusive of caution money and security deposit.

Note: The above refund rules are subject to revision as per UGC notification (as applicable).
