1. Programmes:

Mumbai: Industrial Automation, Computer Engineering and Electronics & Telecommunication Engineering

Shirpur: Computer Engineering, Mechanical Engineering & Industrial Automation

2. **Eligibility Criteria:** Candidate must have minimum 50% marks (as mentioned by University in Final Marksheet) in B.Tech. /B.E. Candidate with valid GATE score will be preferred.

Note:

- Candidates appearing for final year B.Tech /B.E can also apply
- Candidates who have cleared their graduation by doing a part-time course or through distance learning, correspondence courses, externally, open school from recognized University are eligible to apply & register as per UGC guidelines.
- Candidate has to apply & choose preference of relevant branch as per their Bachelors specialization.

Note: For Industrial Automation specialization all branches are eligible except B.E/B.Tech in Civil & Chemical Engineering

8. Refund Rules
