**1. Program : MCA**

This Handout gives information about the Admission Procedure and Admission Test for 3 year MCA for the academic year 2017-18.

**2. Eligibility Criteria :**

Bachelor degree with minimum 50% aggregate marks in Arts, Science, Commerce, Management or any other discipline.

**Note:**

- Candidates appearing for final year can also apply
- Candidates who have cleared their graduation by doing a part-time course or through distance learning, correspondence courses, externally, open school from recognized University are eligible to apply & register as per UGC guidelines.
- Submission of AIU equivalence certificate to confirm the eligibility for the program is mandatory for those candidates who have completed their Under-Graduation from overseas board/ Universities.
