# 1. Program: B.Tech

- > Specialization:
- For Mumbai Campus: Information Technology, Computer, Mechatronics, Mechanical, Civil and Electronics & Telecommunication Engineering
- For Shirpur Campus: Computer, Mechanical, Civil and Electronics & Telecommunication Engineering, Mechatronics and Textile

# Note: Non NMAT candidate will be considered only if vacant seats are available after NMAT merit listed candidates

# 2. Eligibility criteria for (10+2)

➤ Candidate must have passed 10 + 2 or equivalent exam including international IB Diploma (IB certificate awarded is not eligible)

&

With science or science vocational

&

- Minimum 50% marks in PCM for Mumbai campus & 45% marks in PCM for Shirpur campus.
- ➤ Preference will be given to candidates with AIEEE/JEE scores.
- ➤ Candidates who have passed the 10+2 exam by doing a part-time course or through distance learning/correspondence/externally/open school are not eligible to apply for the courses.
- Candidates should present single marksheet .Candidates passed with compartment is not eligible.
- ➤ In case of CBSE, ICSE, Online marks mentioned of HSC, total aggregate percentage should be mentioned in online registration form, not best of four, five or seven.
- > Note (for IB & Cambridge Candidate): Candidates called for admission counseling on the basis of NMAT (UG) merit list & who do not have final marksheet will be given "Provisional Admission "based on predicted score. Fees will be accepted from such candidate but their admission will be confirmed on submission of final marksheet if found eligible before the commencement of the program

# Eligibility (Diploma)

- > Candidates Completed Diploma Engineering with Minimum 50 % is eligible to apply
- > Candidates should present single marksheet. Candidates passed with compartment is not eligible.
- ➤ Candidates who have passed exam by doing a part-time course or through distance learning/correspondence/externally/open school are not eligible to apply for the courses
- Diploma candidates will be considered for admission after 10+2 candidates.
- > Candidate will be admitted based on relevant specialization in Diploma.

#### 4. Admission Process:

Online registration: Registration Online on website www.nmims.edu & Pay fees of Rs.850/- by Credit Card . (Please refer online registration for payment details.) & forward below mentioned documents to:

#### Selection Process:

- **For 10+2 candidate** :Merit list will be prepared on the basis of the performance of the candidate in 10 + 2 or equivalent exam
- **For Diploma candidate**: Merit list will be prepared on the basis of the performance of the candidate in Diploma exam.
- Candidates will be called for counseling session at Mumbai based on the merit list.
- In the counseling session candidates will be given admission to various disciplines as per their merit, choice and availability of discipline as per eligibility criteria.
- The decision of the institute will be final in this regard and no inquiries or correspondence in this regard will be entertained

#### Upgradation Process:

- On cancellation the vacant seat will be offered to next eligible candidate as per merit and preference.
- Candidate has to confirm the offer in writing within 24 hrs. If accepted, gets transferred to that specialization. If rejected, not eligible for further up gradation and remains in the same admitted specialization

## Merit Tie: Determination of merit in case of tie.

If two or more candidates secure equal number of marks in 10 + 2 or equivalent exam /Diploma exam, their relative merit will be decided as per following order:

### For 10+2 Candidate:

- (a) Candidate securing higher marks in the subject of Physics
- (b) Candidate securing higher marks in the subject of mathematics
- (c) Candidate securing higher marks in the subject of Chemistry

# For Diploma Candidate

a) Candidate securing higher aggregate percentage marks in 10th examination

#### ➤ Refund Rules:

Candidate should submit a written request for withdrawal / cancellation of admission & submit it to Deputy Registrar (Admission) along with original fee receipt.
