Refund Rules: The Schedule of refund of fees will be as follows as per UGC rule Oct 2018.

If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution concerned shall follow the following five-tier system for the refund of fees remitted by the student.

Sr. No.	Percentage of Refund of Aggregate fees*	Point of time when notice of withdrawal of admission is served to HEI
(1)	100%	15 days or more before the formally-notified last date of admission (on or before 15 th July 2019)
(2)	90%	Less than 15 days before the formally-notified last date of admission. (i.e. from 16 th July 2019 to 31 st July 2019)
(3)	80%	15 days or less after the formally-notified last date of admission (i.e. from 1 st August 2019 to 15 th August 2019)
(4)	50%	30 days or less, but more than 15 days, after formally-notified last date of admission (i.e. 16 th August 2019 to 30 th August 2019)
(5)	00%	More than 30 days after formally-notified last date of admission (i.e. from 31st August 2019 onwards)

In case of (1) in the table above, the deduction will be 5% of the fees paid as processing charges from the refundable amount, subject to a maximum of Rs 5,000/-.
