**1. Program:**

**B.Tech. (for vacant seats only)**

➤ **Specialization:**

- **For Mumbai Campus:** Information Technology, Electronics & Telecommunication Engineering, Computer Engineering, Computer Science & Business System, Mechanical, Civil, Mechatronics, Data Science., B Tech Computer Science & Engg (Artificial Intelligence), B Tech Computer Science & Engg (Cyber Security).
- **For Shirpur Campus:** Information Technology, and Computer Engineering.
- **For Navi Mumbai & Indore Campus:** Computer Science & Business System (CSBS).

**MBA Tech. (for vacant seats only)**

➤ **Specialization:**

- **For Mumbai Campus:** Information Technology, Electronics & Telecommunication Engineering, Computer Engineering, Chemical, and Mechanical.
- **For Shirpur Campus:** Information Technology, and Computer Engineering.
- **For Navi Mumbai & Indore Campus:** Computer Engineering.

**Important :**

- **Vacant seats will be calculated after NMIMS student's internal transfer to MBA Tech. and B.Tech. program.**
- **Further admissions will be done by counseling.**
- **MBA Tech. Admissions will be conducted first.**
- **Candidates securing admission in MBA Tech. will not be considered for B.Tech. admissions.**
- **Detail schedule will be displayed separately in admission letter.**
- **Existing NMIMS/MPSTME/STME candidates cannot apply for this process.**

**2. Eligibility Criteria:**

**MBA Tech.**

- **Candidates passing First Year of B. Tech. / B.E. with CGPA  $\geq$  3.00 out of 4.00 or equivalent marks (aggregate) and no Backlog of First year.**

- Candidates passing Diploma with minimum 80 % (aggregate score as mentioned in final marksheet) or equivalent at Diploma
- For Second Year MBA Tech. seats, candidates passing First year B.Tech. / B.E. will be given preference. If any seats remain vacant thereafter Diploma candidates will be considered in their respective branches / streams only.

**B.Tech.**

- Candidates passing Diploma with minimum 60% (aggregate score as mentioned in final marksheet)
- Candidates passing First Year of B. Tech. / B.E. with CGPA  $\geq$  3.00 out of 4.00 or equivalent marks (aggregate) and no Backlog of First year.
- For Second Year B. Tech. seats Diploma candidates will be given preference. If any seats remain vacant thereafter candidates passing first year of B.Tech. will be considered.
- Candidates are required to mention aggregate percentage given in final year marksheet for Diploma candidate & CGPA / aggregate Percentage given in first year mark sheet for First year Engineering candidates in online registration form.
- **Candidate will not be considered for merit list if they fail to mention / update the same in online registration form or their result is not available during this period.**
- Candidates awaiting result are not eligible to apply.
- Submission of AIU equivalence certificate to confirm the eligibility for the program is mandatory for those candidates who have completed their Under-Graduation from overseas board/ Universities.
- It is the sole responsibility of the candidate to ensure that correct marks are entered.
- At any given point of time it is found that the information given by candidate i.e. 10<sup>th</sup>, Diploma/First year Degree Exam Score is incorrect, the candidate admission will be cancelled and fees will be forfeited
- Candidate above 25 years of age are not eligible to apply
- Candidate has to apply & choose preference of relevant branch only

3. **Duration:** Three Years Full-time for B.Tech. Second year direct admission & Four-year Full Time for MBA Tech Second Year admissions.

4. **Online Registration & Payment of fees:**

- Online Registration Fee of Rs. 1,000/- plus applicable taxes (Please refer online registration for payment details.)
- Registration Fee is **non-refundable**.

5. **Selection Process:**

- Merit list will be prepared based on the performance of candidate in Diploma / 1<sup>st</sup> year engineering examination.
- The decision of the institute will be final in this regard and no inquiries or correspondence in this regard will be entertained

**Merit Tie: Determination of merit in case of Tie:** If two or more candidates secure equal number of marks in Diploma / 1<sup>st</sup> year engineering, their relative merit will be decided based on candidate securing higher aggregate Percentage marks in 10<sup>th</sup> examination.

7. **Refund Rules:** The Schedule of refund of fees will be as follows as per UGC rule October 2018:

If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution concerned shall follow the following five-tier system for the refund of fees remitted by the student.

Sr. No.	Percentage of Refund of Aggregate fees	Point of time when notice of withdrawal of admission is served to HEI
(1)	<b>100%</b>	15 days or more before the formally-notified last date of admission
(2)	<b>90%</b>	Less than 15 days before the formally-notified last date of admission
(3)	<b>80%</b>	15 days or less after the formally-notified last date of admission
(4)	<b>50%</b>	30 days or less, but more than 15 days, after formally-notified last date of admission
(5)	<b>00%</b>	More than 30 days after formally-notified last date of admission

In case of (1) in the table above, the deduction will be 5% of the fees paid as processing charges from the refundable amount, subject to a maximum of Rs 5,000/-.

Note: The above refund rules are subject to revision as per UGC notification (as applicable).

- Candidate's documents will be verified at the time of admission (if selected) & if found not eligible admission will be cancelled and fees will be forfeited
- **For cancellation/ withdrawal of admission:** Withdrawal / cancellation means voluntary withdrawal / cancellation by candidate for any reason.
