#### 2. Eligibility Criteria:

Candidate must have minimum aggregate 55% marks or CGPA>3.0 out of 4 in B.Tech. / B.E. (all streams) or M.Sc.

– Maths, Statistics, Computer Sciences, IT, Electronics or MCA or AMIE or any other equivalent UGC approved qualification for M.Tech.

#### Note:

- Candidates appearing for final year B.Tech. / B.E. can also apply
- Candidates who have cleared their graduation by doing a part-time course or through distance learning, correspondence course, externally, open school from recognized University are eligible to apply & register as per UGC guidelines.
- Submission of AIU equivalence certificate to confirm the eligibility for the program is mandatory for those candidates who have completed their Under-Graduation from overseas board/ Universities.
- Candidate has to apply & choose preference of relevant branch as per their Bachelors specialization.

- Candidates are required to download the call letter from our website <u>www.nmims.edu</u> and upload below mentioned document. No separate call letter will be mailed or posted to the candidates. It is important and primary requirement to upload the mandatory documents before Entrance Test / Personal Interview.

8. Refund Rules: The Schedule of refund of fees will be as follows as per UGC rule October 2018.

The Schedule of refund of fees will be as follows:

If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution concerned shall follow the following five-tier system for the refund of fees remitted by the student.

Sr. No.	Percentage of Refund of Aggregate fees	Point of time when notice of withdrawal of admission is served to HEI
(1)	100%	15 days or more before the formally-notified last date of admission (on or before 1st July 2020)
(2)	90%	Less than 15 days before the formally-notified last date of admission. (i.e. from 2 <sup>nd</sup> July 2020 to 17 <sup>th</sup> July 2020)
(3)	80%	15 days or less after the formally-notified last date of admission (i.e. from $18^{th}$ July 2020 to $1^{st}$ August 2020)
(4)	50%	30 days or less, but more than 15 days, after formally-notified last date of admission (i.e. 2 <sup>nd</sup> August 2020 to 16 <sup>th</sup> August 2020)
(5)	00%	More than 30 days after formally-notified last date of admission (i.e. from 17 <sup>th</sup> August 2020 onwards)

In case of (1) in the table above, the deduction will be 5% of the fees paid as processing charges from the refundable amount, subject to a maximum of Rs 5,000/-.

Note: The above refund rules are subject to revision as per UGC notification (as applicable).

#### 9. Important Instructions:

- Please see the important dates and preserve it as a guide. All announcements from the University will be through its website <u>www.nmims.edu</u> and there will be no separate mail sent. Kindly check website for regular updates.
- It is the sole responsibility of the candidate to check whether he/she is eligible for the program as per the eligibility criteria stated above.
- Admission for appearing candidates will be provisional till submission of Final Marksheet and will be confirmed on submission & if found eligible as per eligibility criteria.
- Canvassing in any form will disqualify the candidate.
- Candidates are required for admission process in person.

- Candidate's documents will be verified at the time of admission (if selected) & if found not eligible admission will be cancelled and fees will be forfeited.
- For cancellation/ withdrawal of admission: Withdrawal / cancellation means voluntary withdrawal / cancellation by candidate for any reason.
