Refund Rules: The Schedule of refund of fees will be as follows as per UGC rule October 2018:

If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution concerned shall follow the following five-tier system for the refund of fees remitted by the student.

Sr. No.	Percentage of Refund of Aggregate fees	Point of time when notice of withdrawal of admission is served to HEI
(1)	100%	15 days or more before the formally-notified last date of admission (on or before 1^{st} July 2020)
(2)	90%	Less than 15 days before the formally-notified last date of admission. (i.e. from 2^{nd} July 2020 to 17^{th} July 2020)
(3)	80%	15 days or less after the formally-notified last date of admission (i.e. from 18^{th} July 2020 to 1^{st} August 2020)
(4)	50%	30 days or less, but more than 15 days, after formally-notified last date of admission (i.e. 2 nd August 2020 to 16 th August 2020)
(5)	00%	More than 30 days after formally-notified last date of admission (i.e. from 17 th August 2020 onwards)

In case of (1) in the table above, the deduction will be 5% of the fees paid as processing charges from the refundable amount, subject to a maximum of Rs 5,000/-.
