1. Programmes:

Mumbai Campus: Data Science (Business Analytics), Artificial Intelligence.

2. Eligibility Criteria:

Candidate must have minimum aggregate 55% marks or CGPA>3.0 out of 4 in B.Tech. / B.E. (all streams) or M.Sc. – Maths, Statistics, Computer Sciences, IT, Electronics or MCA or AMIE or any other equivalent UGC approved qualification for M.Tech.

Note:

- Candidates appearing for final year B.Tech. / B.E. can also apply
- Candidates who have cleared their graduation by doing a part-time course or through distance learning, correspondence course, externally, open school from recognized University are eligible to apply & register as per UGC guidelines.
- Submission of AIU equivalence certificate to confirm the eligibility for the program is mandatory for those candidates who have completed their Under-Graduation from overseas board/ Universities.
- Candidate has to apply & choose preference of relevant branch as per their Bachelors specialization.

5. Online Registration & Payment of Registration Fee:

5.1 Online registration:

- Visit www.nmims.edu for online registration.
- Before filling the online form, please read all the instruction carefully mentioned in instruction sheet, important dates and also terms & condition given in online application form.

5.2 Payment of registration fee:

- Register Online on website www.nmims.edu & Pay registration fee of Rs 1,100/- (Non-refundable) (Please refer online registration for payment details)
- On the basis of information indicated in the Application Form, call letter for Entrance Test & Personal Interview will be communicated to the candidate as per important dates through the NMIMS website.
- Candidates are required to download the call letter from our website www.nmims.edu and upload below mentioned document. No separate call letter will be mailed or posted to the candidates. It is important and primary requirement to upload the mandatory documents before Entrance Test / Personal Interview.

The list of mandatory documents is as follows:

- Degree Marksheet & Certificate (for passed candidate)
- 10+2 Examination Passed Marksheet and Certificate
- 10 Examination Passed Marksheet and certificate
- Photo ID proof - Aadhaar Card / Passport / Voter ID / Driving License (Learner license will not be accepted)
- Candidate's application form will not be considered, if they fail to upload the above mentioned documents till 21st April 2021 before 12.00 noon.
- No candidate without call letter will be permitted to appear for the entrance test & personal interview.

6. Selection Process: Entrance Test & Personal Interview

A) Entrance Test (25 questions, 50 marks)

• Structure of the Test

Engineering Mathematics (Calculus, Linear Algebra, Permutation and combination, etc.)	15 Marks
Probability and Statistics	15 Marks
Programming concepts	20 Marks

• Instruction for Test

- Duration: 50 minutes

- All Questions are Compulsory & in multiple choice format
- Wrong answer carries negative marking (so please do not guess!!)
- Use of Simple Calculator is allowed

B) Personal Interview (50 marks).

- Personal Interview – will held either virtual or in presence, that will be communicated in the call letter.
- Total marks = 50 marks
- Final merit list will be based on Entrance Test & Personal Interview
- Admission offer is given as per the merit and vacancy available. WAITLISTED candidates have to check their merit list status as per the date given on the website. SELECTED candidate should upload necessary required documents at the link provided in the admission offer letter, and after verification of the documents, the candidate will get the payment details (RTGS/NEFT details) for the payment of course fees within the stipulated time frame.

8. **Refund Rules:** The Schedule of refund of fees will be as follows as per UGC rule October 2018.

The Schedule of refund of fees will be as follows:

If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution concerned shall follow the following five-tier system for the refund of fees remitted by the student.

Sr. No.	Percentage of Refund of Aggregate fees	Point of time when notice of withdrawal of admission is served to HEI
(1)	100%	15 days or more before the formally-notified last date of admission
(2)	90%	Less than 15 days before the formally-notified last date of admission
(3)	80%	15 days or less after the formally-notified last date of admission
(4)	50%	30 days or less, but more than 15 days, after formally-notified last date of admission
(5)	00%	More than 30 days after formally-notified last date of admission

In case of (1) in the table above, the deduction will be 5% of the fees paid as processing charges from the refundable amount, subject to a maximum of Rs 5,000/-.

Note: The above refund rules are subject to revision as per UGC notification (as applicable).

9. **Important Instructions:**

- Please see the important dates and preserve it as a guide. All announcements from the University will be through its website www.nmims.edu and there will be no separate mail sent. Kindly check website for regular updates.
- It is the sole responsibility of the candidate to check whether he/she is eligible for the program as per the eligibility criteria stated above.

- Admission for appearing candidates will be provisional till submission of Final Marksheet and will be confirmed on submission & if found eligible as per eligibility criteria.
- Canvassing in any form will disqualify the candidate.
- Candidates are required for admission process in person.
- Candidate's documents will be verified at the time of admission (if selected) & if found not eligible admission will be cancelled and fees will be forfeited.
- **For cancellation/ withdrawal of admission:** Withdrawal / cancellation means voluntary withdrawal / cancellation by candidate for any reason. Candidate should email at admissioncancellation@nmims.edu, the soft copy of admission cancellation form duly filled and signed (form available on www.nmims.edu & <https://www.nmims.edu/students/>, fee paid receipt copy & cancelled cheque (personal account only).
- If at any stage, it is found that a candidate does not satisfy the eligibility criteria or the information furnished by him/her is incorrect, then application for the admission to the Program, even if selected and fees paid, will stand cancelled and fees will be forfeited.
- NMIMS has full right to disqualify a candidate at any stage of admission process if found ineligible.
- All matters of dispute will be subject to the legal jurisdiction of Mumbai only.
