Refund Rules: The Schedule of refund of fees will be as follows as per UGC rule October 2018:

If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution concerned shall follow the following five-tier system for the refund of fees remitted by the student.

Sr. No.	Percentage of Refund of Aggregate fees*	Point of time when notice of withdrawal of admission is served to HEI
1	100%	15 days or more before the formally-notified last date of admission (on or before 10th August 2020)
2	90%	Less than 15 days before the formally-notified last date of admission. (i.e. from 11th August 2020 to 26th August 2020)
3	80%	15 days or less after the formally-notified last date of admission (i.e from 27th August to 10th September 2020)
4	50%	30 days or less, but more than 15 days, after formally-notified last date of admission (i.e 11th September 2020 to 25th September 2020)
5	0%	More than 30 days after formally-notified last date of admission (i.e from 26th September 2020 onwards)

In case of (1) in the table above, the deduction will be 5% of the fees paid as processing charges from the refundable amount, subject to a maximum of Rs 5,000/-.
