**1. Program : B.Tech (for Mumbai Campus only)**

**Streams:**

- **Mechanical Engineering (60 Seats)**
- **Computer Engineering (180 Seats)**
- **Data Science (60 seats)**
- **Information Technology (60 seats)**

**2. Eligibility criteria**

"The Candidate must have passed the SSC (Std X) examination or its equivalent, by securing 65% of aggregate marks in subjects General Sciences and Mathematics OR Physics, Chemistry or any other Science subject and Mathematics"

**2.1 For Maharashtra State Board Candidates: -**

- I. Candidates who have passed Maths / Mathematics (Code 71 for Maharashtra State Board Candidates) and Science & Technology (Code 72 for Maharashtra State Board candidates) are only eligible for admission.

**2.2 For CBSE / ICSE / IGCSE Candidates: -**

- I. General Science / Physics & Chemistry or any other science subject with Mathematics subjects' marks shall be considered in aggregate marks.
- II. Other vocational subjects / combination will not be considered in aggregate.

**Note:**

- a) Only single marksheet with all compulsory subjects taken and passed in first attempt is mandatory, no compartmentalized marksheet will be considered.
- b) Those candidates who have passed, or, are appearing for 10<sup>th</sup> examination from a Board / University where Grade Point Average is given, such candidates must produce in writing from the Board / University concerned, the equivalent percentage for the GPA obtained.
- c) Candidate above 20 years of age are **NOT ELIGIBLE** to apply (applicable for all boards).

- d) Candidates passing 10<sup>th</sup> or equivalent examination from Open or Distance learning (ODL) school recognized only by National Institute of Open schooling (NIOS) can apply for the program subject to fulfilling the eligibility of the program.
- e) Candidate whose final mark sheet is not available at the time of admission are required to submit final copy of result duly attested by Principal of the school / college before the course commencement date, failing which candidate will not be admitted.
- f) Submission of AIU equivalence certificate to confirm the eligibility for the program is mandatory for those candidates who have completed their 10<sup>th</sup> or equivalent examination from overseas Board / Universities.
- g) All admission will be completed on provisional basis, subject to the fulfillment of eligibility criteria mentioned in the point no. 2 and the decision of the institute will be final in this regard.
- h) Candidates appearing for their final 10<sup>th</sup> or equivalent examination can also apply provided they should fulfill / meet minimum cut off marks and should be eligible & produce all the necessary documents in original at the time of admission.
- i) It is the sole responsibility of the candidate to ascertain whether they possess necessary and requisite qualification for admission to courses at NMIMS.

#### 4.1 Online Registration & Payment of Registration Fee:

- a) Online Registration Fee of Rs. 1,000/- plus GST if applicable (Please refer online registration for payment details)
- b) Registration Fee is **NON-REFUNDABLE / NON-TRANSFERABLE**.
- c) Candidates are requested to select the Preference/d carefully while registration. The same would be considered for merit process. Preference/s once selected, cannot be changed for any reason.
- d) Internal / Stream Transfer will be not entertained at any reason.
- e) Candidate has to provide two preferences compulsory from available specializations in the registration form.

#### 4.2 Selection Process:

- a) Merit list will be prepared on the basis of the performance of the candidate in 9<sup>th</sup> or equivalent exam aggregate marks (including Semester 1 & Semester 2, aggregate marks wherever is applicable) AND the Preferences mentioned in the registration form.
- b) Candidate can check their Merit / Offer status from their dashboard as per the specified in important dates.
- c) If the candidate has entered wrong marks in online registration form, then the candidate will be disqualified for further admission process. In any stage if it is found that, the 9<sup>th</sup> / 10<sup>th</sup> examination marks given by the candidate in application form is different from the marks actually obtained (as per marksheet) such candidate's admission will be cancelled and fees will be forfeited.
- d) The decision of the institute will be final in this regard and no inquiries or correspondence in this regard will be entertained.

#### **Note:**

- a) Candidates are required to update 9<sup>th</sup> or equivalent examination aggregate marks along with Maths, Science and English marks in online registration form. **Candidate will not be considered for merit list if they fail to update the same in online registration form or if their result is not available during this period.**
- b) **The Candidates who have passed 9<sup>th</sup> Examination, the aggregate / total marks shall be total marks of all subjects taken into consideration and mentioned on the marksheet of both semesters where it is applicable.**
- c) Student seeking admission on the basis of Group 1 & Group 2 subjects only, the **aggregate marks** shall be the grand total of marks in all subjects from Group 1 & Group 2 where he/she has scored maximum marks.
- d) Student seeking admission on the basis of Group 1, Group 2 & Group 3, **aggregate marks** shall be the grand total of all subjects from all groups.
- e) At any given point of time it is found that the information given by candidate i.e. 9<sup>th</sup> or 10<sup>th</sup> exam Score is incorrect, the candidate admission will be cancelled and fees will be forfeited. Therefore, its sole responsibility of the candidate to ensure that correct marks are entered.

## 5 Program Fees

The provisional fees for Batch 2023 is Rs. 2,25,000/-. It is mandatory to candidate to pay the difference of fees amount if any within given time-frame, once the fees amount is finalized by NMIMS Management.

- If candidate **fail to** pay the difference amount, NMIMS has right to cancel the provisional admission on account of "NON-PAYMENT OF PROGRAM FEES" and **refund will be as per NMIMS refund policy**.
- Candidate can't claim to regularize the provisional admission merely on the basis of payment of provisional fees.
- Candidate has to submit undertaking accordingly at the time of his provisional admission.

## 6 Refund Rules: The Schedule of refund of fees will be as follows:

If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution concerned shall follow the following five-tier system for the refund of fees remitted by the student.

Sr. No.	Percentage of Refund of Aggregate fees*	Point of time when notice of withdrawal of admission is served to HEI
(1)	100%	15 days or more before the formally-notified last date of admission
(2)	90%	Less than 15 days before the formally-notified last date of admission.
(3)	80%	15 days or less after the formally-notified last date of admission
(4)	50%	30 days or less, but more than 15 days, after formally-notified last date of admission
(5)	00%	More than 30 days after formally-notified last date of admission

In case of (1) in the table above, the deduction will be 5% of the fees paid as processing charges from the refundable amount, subject to a maximum of Rs 5,000/-.

Note: The above refund rules are subject to revision as applicable.

## 7 Important Instructions

- a) Candidates will be offered Programme based on the availability of seat, candidates merit rank, choice.
- b) Please see the important dates and preserve it as a guide. All announcements from the University will be through its website [www.bti.nmims.edu](http://www.bti.nmims.edu) or [www.nmims.edu](http://www.nmims.edu) and there will be no separate mail sent. **Kindly check website / dashboard regularly for any updates. (www.bti.nmims.edu or www.nmims.edu).**
- c) It is the sole responsibility of the candidate to check whether he/she is eligible for the program as per the eligibility criteria stated above.
- d) Canvassing in any form will disqualify the candidate.

- e) The X / XII / Graduation (Qualified) examination should have been conducted before the course commencement date.
- f) Candidates whose final mark sheet of the qualified examination is not available at the time of their provisional admission, is required to submit their final marksheet copy as soon as the result declared. In such case, if the candidate fail to meet the required eligibility criteria then his admission will be cancelled and the fees will be refunded as per NMIMS refund rules (even after course commencement).
- g) If at any stage, it is found that a candidate does not satisfy the eligibility criteria or the information furnished by him/her is incorrect, then the application for the admission to the Program, even if selected and fees paid, will stand cancelled and fees will be forfeited.
- h) **For cancellation / withdrawal of admission:** The Candidate has to upload the soft copy of admission cancellation form duly filled and signed (form available on fees receipt copy and cancelled cheque (personal account only) to <https://upload.nmims.edu/admission/cancellation/>
- i) NMIMS University has full right to disqualify a candidate at any stage of admission process if found ineligible.
- j) If there are multiple / duplicate registrations, then registration for the said program will not be considered & registration fee will be forfeited.
- k) All matters of dispute will be subject to the legal jurisdiction of Mumbai only.
