**Refund Rules:** The Schedule of refund of fees will be as follows as per UGC rule October 2018:

If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution concerned shall follow the following five-tier system for the refund of fees remitted by the student.

Sr. No.	Percentage of Refund of Aggregate fees*	Point of time when notice of withdrawal of admission is served to HEI
(1)	<b>100%</b>	15 days or more before the formally-notified last date of admission (on or before 1 <sup>st</sup> July 2019)
(2)	<b>90%</b>	Less than 15 days before the formally-notified last date of admission. (i.e. from 2 <sup>nd</sup> July 2019 to 17 <sup>th</sup> July 2019)
(3)	<b>80%</b>	15 days or less after the formally-notified last date of admission (i.e from 18 <sup>th</sup> July 2019 to 1 <sup>st</sup> August 2019)
(4)	<b>50%</b>	30 days or less, but more than 15 days, after formally-notified last date of admission (i.e 2 <sup>nd</sup> August 2019 to 16 <sup>th</sup> August 2019)
(5)	<b>00%</b>	More than 30 days after formally-notified last date of admission (i.e from 17 <sup>th</sup> August 2019 onwards)

**\*(Inclusive of course fees and non-tuition fees but exclusive of caution money and security deposit)**

In case of (1) in the table above, the deduction will be 5% of the fees paid as processing charges from the refundable amount, subject to a maximum of Rs 5,000/-.
