1. Programmes:

M.Tech. – Cybersecurity & Forensics

2. Eligibility Criteria:

Candidate must have minimum aggregate 60% marks or CGPA \geq 3.0 out of 4 in B.Tech. / B.E. in the relevant area of specialization or M.Sc..(IT / Computer Science) **or** MCA **or** any other equivalent UGC approved qualification for M.Tech.

Note:

- Candidates appearing for final year B.Tech. / B.E. can also apply
- Candidates who have cleared their graduation by doing a part-time course or through distance learning, correspondence course, externally, open school from recognized University are eligible to apply & register as per UGC guidelines.
- Submission of AIU equivalence certificate to confirm the eligibility for the program is mandatory for those candidates who have completed their Under-Graduation from overseas board/ Universities.
- Candidate has to apply & choose preference of relevant branch as per their Bachelors specialization.

3. Duration : 2 Years, Full-time

4. Intake : 25 seats (Mumbai campus only)

5. Registration & Payment of Registration Fee:

5.1 Online registration:

- Visit www.nmims.edu for registration form.
- Download registration form & fill the same. Please read all the instruction carefully mentioned in instruction sheet and important dates.

5.2 Payment of registration fee:

- Pay registration fee of Rs 1,100/- (Non-refundable) through demand draft in favour of "**SVKM's NMIMS**" payable at Mumbai.

- Candidate's application form will not be considered if they fail to submit the above mentioned document on or before 20th June 2019.

6. **Selection Process:** Personal Interview.

- Personal Interview will be conducted in Mumbai only.
- Merit list will be prepared based on performance of candidate in Personal Interview.

7. **Program Fee:**

Fees for the current year will be intimated at the time of admission.

8. **Refund Rules:** The Schedule of refund of fees will be as follows as per UGC rule October 2018:

If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution concerned shall follow the following five-tier system for the refund of fees remitted by the student.

Sr. No.	Percentage of Refund of Aggregate fees*	Point of time when notice of withdrawal of admission is served to HEI
(1)	100%	15 days or more before the formally-notified last date of admission (on or before 1 st July 2019)
(2)	90%	Less than 15 days before the formally-notified last date of admission. (i.e. from 2 nd July 2019 to 17 th July 2019)
(3)	80%	15 days or less after the formally-notified last date of admission (i.e from 18 th July 2019 to 1 st August 2019)
(4)	50%	30 days or less, but more than 15 days, after formally-notified last date of admission (i.e 2 nd August 2019 to 16 th August 2019)
(5)	00%	More than 30 days after formally-notified last date of admission (i.e from 17 th August 2019 onwards)

***(Inclusive of course fees and non-tuition fees but exclusive of caution money and security deposit)**

In case of (1) in the table above, the deduction will be 5% of the fees paid as processing charges from the refundable amount, subject to a maximum of Rs 5,000/-.

Note: The above refund rules are subject to revision as per UGC notification (as applicable).

9. **Important Instructions**

- Please see the important dates and preserve it as a guide. All announcements from the University will be through its website www.nmims.edu and there will be no separate mail sent. Kindly check website for regular updates.
- It is the sole responsibility of the candidate to check whether he/she is eligible for the program as per the eligibility criteria stated above.
- Admission for appearing candidates will be provisional till submission of Final Marksheet and will be confirmed on submission & if found eligible as per eligibility criteria.
- Canvassing in any form will disqualify the candidate
- Candidates are required for admission process in person
- Candidate's documents will be verified at the time of admission (if selected) & if found not eligible admission will be cancelled and fees will be forfeited
