- 1. **Programme:** PGD in Real Estate Construction and Management
- 2. Eligibility Criteria: Bachelors' Degree in any discipline.

Note:

- Candidates who have cleared their graduation from a recognized University are eligible to apply.
- Candidates who have cleared their graduation by doing a part-time course or through distance learning, correspondence courses, externally, open school from recognized University are eligible to apply & register as per UGC guidelines.
- Candidates who have appeared for their final year degree examination can also apply, however their admission will be provisional and will be confirmed only after producing the results on or before 15th July 2018.
- Submission of AIU equivalence certificate to confirm the eligibility for the program is mandatory for those candidates who have completed their Under-Graduation from overseas board / Universities.
- 3. **Duration**: 2 years, Full-time.
- 4. Intake: 30 per batch

- 6. Selection Process: Personal Interview (Total 100 marks)

Merit list will be prepared based on performance of candidate in Personal Interview.

7. Program Fee

Fees for Batch 2018-2019 : Rs. 5,00,000/- p.a.

Fees for the current year will be intimated at the time of admission.

8. Refund Rules: The Schedule of refund of fees will be as follows as per UGC rule October 2018:

If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution concerned shall follow the following five-tier system for the refund of fees remitted by the student.

Sr. No.	Percentage of Refund of Aggregate fees*	Point of time when notice of withdrawal of admission is served to HEI
(1)	100%	15 days or more before the formally-notified last date of admission (on or before 15 th July 2019)
(2)	90%	Less than 15 days before the formally-notified last date of admission. (i.e. from 16 th July 2019 to 31 st July 2019)
(3)	80%	15 days or less after the formally-notified last date of admission (i.e from 1st August 2019 to 15th August 2019)
(4)	50%	30 days or less, but more than 15 days, after formally-notified last date of admission (i.e 16 th August 2019 to 30 th August 2019)
(5)	00%	More than 30 days after formally-notified last date of admission (i.e from 31st August 2019 onwards)

^{*(}Inclusive of course fees and non-tuition fees but exclusive of caution money and security deposit)

In case of (1) in the table above, the deduction will be 5% of the fees paid as processing charges from the refundable amount, subject to a maximum of Rs 5,000/-.

Note: The above refund rules are subject to revision as per UGC notification (as applicable).

- Candidate's documents will be verified at the time of admission (if selected) & if found not eligible admission will
 be cancelled and fees will be forfeited
