#### 1. Introduction :

NMIMS Deemed to be University (as per UGC / AICTE Norms) has launched the postgraduate MCA program at Mukesh Patel School of Technology Management & Engineering, Mumbai campus. It is two years, full time PG degree. The courses conduct here, as part of the curriculum, are helpful in strengthening the students' ability to efficiently approach problems and bring out effective solutions. We provide a wide range of electives from second semester onwards, to gain knowledge and a research orientation as per industry requirements. This Handout gives information about the admission procedure and admission test for two-year MCA for the academic year 2025 Batch.

#### 2. Program & Intake:

\*Program will commence only if there are a minimum of 20 eligible candidates admitted after the selection process.

**Admission for MCA program through written test conducted by NMIMS and Graduation pre final year CGPA / percentage.**

#### 3. Eligibility Criteria:

3.1 Passed BCA / Bachelor Degree in Computer Science Engineering or equivalent Degree.




Passed B.Sc. / B.Com. / B.A. / BMS with Mathematics at 10+2 Level or at Graduation Level (with additional bridge Courses as per the norms of the concerned University). Obtained **at least 50% marks** in the qualifying examination.

3.2 Candidates should mention in the online registration / e-admission form (if selected) all the subjects which the candidate has taken & appeared for (not best of four, five, six or seven). The candidate shall have passed all the subjects, which he / she has taken & appeared for in the applicable examination/s. The aggregate percentage of all subjects which the candidate has taken & appeared for will be taken

into consideration for confirming the eligibility of the candidate for the program at the time of admission.

- 3.3 In case the mark sheet issued by applicable board / University is in percentile/s or Grade point the actual aggregate percentage of all subjects appeared by the candidate will be taken into consideration.
- 3.4 Candidate awaiting the results of the final year examination may also apply.
- 3.5 Candidates called for admission on the basis of merit list and who do not have final mark sheet will be given "**Provisional Admission**". Fees will be accepted from such candidates but their admission will be confirmed on submission of final mark sheet.
- 3.6 Candidate whose final marksheet is not available at the time of admission are required to submit internet / Digi-locker copy of result duly attested by Principal of the college, failing which candidate will not be admitted to the program.
- 3.7 Submission of AIU equivalence certificate to confirm the eligibility for the program is mandatory for those candidates who have completed their examination from Overseas Universities. Applicable to candidates of distance learning/ correspondence course/ open school too who have completed their examination from overseas Board / Universities. If AIU not submitted, then the candidate will be considered as **not eligible**.
- 3.8 Candidates who have cleared their graduation by doing a part-time course or through distance learning, correspondence courses, externally, open school from recognized University are eligible to apply & register as per UGC guidelines.
- 3.9 Candidates whose final mark sheet of the qualified examination is not available at the time of their provisional admission, is required to submit their final marksheet copy as soon as the result declared. In such case, if the candidate fail to meet the required eligibility criteria then his admission will be cancelled and the fees will be refunded as per NMIMS refund rules (even after course commencement).
- 3.10 The Graduation (Qualified) examination should have been conducted before the course commencement date.
- 3.11 Mark sheet / Transcripts issued by Board / University only be considered (School / Institute will not be accepted).
- 3.12 It is sole responsibility of the candidate to ascertain whether they possess necessary and requisite qualification for admission to courses at NMIMS University.

##### 4.1 Payment of registration fee (Step-1) :

- The online registration fee of Rs 2,500/-
- Registration Fee is non-refundable / Non-transferable.

##### 4.2 Entrance Test: Written Test (Step 2) :

- List of Documents to be uploaded for to appear written test:
  - Copy of duly filled online application form
  - 10<sup>th</sup> mark sheet & passing certificate
  - (10+2) or equivalent mark sheet and passing certificate

- Degree mark sheet & Degree certificate (if applicable)
- Entrance Test will be scheduled as per the important dates mentioned on the website at Mumbai campus only.
- The candidate must be available as per the mentioned time given in the call letter.
- **Selection Process: written test conducted by NMIMS**
- Written Test: Total Marks = 50 marks  
Examination type: MCQ  
Total number of questions: 50  
Total marks: 50  
Duration: 1.00 Hrs.

Syllabus:

1. Knowledge of computing (Awareness) - 30 Questions (30 Marks)
  1. Data structures (computer programming)
  2. Algorithms
  3. Networking
  4. Operating systems
2. Logical and verbal Reasoning - 20 Questions (20 Marks)

- **The final merit is based on the performance in written test and weightages of each component which is give below:**

- **Guidance note is available on candidate dashboard to calculate pre- final year CGPA / Aggregate Percentage**
- Admission offer is given as per the merit and vacancy available. WAITLISTED candidates have to check their merit list status as per the date given on the website. SELECTED candidate should upload necessary required documents and pay the full course fees at the link given in respective candidate's log-in within the stipulated given time frame. Kindly note that only those candidates who complete the process by paying fees will be admitted to the program.
- The selection will be solely based on merit.
- The cut-off for deciding the merit shall lie solely with NMIMS.

**5. Program Fee:**

Fees for Batch 2024 was Rs. 3,25,000/- p.a. (For information only).

**Fees for current year (Batch 2025) will be intimated at the time of admission.**

6. **Refund Rules:** As per the notification of UGC. Details will be shared at the time of admission.

#### 7. **Important Instructions:**

- **For cancellation / withdrawal of admission:** Withdrawal / cancellation means voluntary withdrawal / cancellation by candidate for any reason. Candidate has to upload cancellation form duly filled and signed, fees paid receipt copy & cancelled cheque (personal account) to mentioned link : <https://upload.nmims.edu/admission/cancellation/>
- Please see the important dates and preserve it as a guide. All announcements from the institute will be through its website [www.nmims.edu](http://www.nmims.edu) / on the candidate's dashboard and no individual communication will be sent to the candidates. Kindly check the website regularly for any updates.
- If at any stage, it is found that a candidate does not satisfy the eligibility criteria or the information furnished by him/ her in the application form is incorrect, his/her application for the admission to the program, even if selected, will stand cancelled and fees will be refunded as per NMIMS refund policy.
- Admission to program is considered as "**Provisional Admission**" till all required and mandatory documents are submitted by the candidate and the same is verified and approved. If it is found that the candidate is not eligible at any stage (even after the course commencement), admission will be cancelled and fees will be refunded as per refund rule clauses even if selected / admitted to the program.
- Canvassing in any form will disqualify the candidate.
- NMIMS has full right to disqualify a candidate at any stage of admission process if found ineligible. No separate intimation will be given.
- It is the sole responsibility of the candidate to ascertain whether they possess the necessary and requisite qualification for the admission at NMIMS, as verification of the documents is done at the time of final admission.
