NMIMS Entrance Test for UG Admissions For Academic year 2026-27

SVKM's NMIMS conducts the UG Entrance examination every year for class XII passed out / appearing candidates to be eligible to their UG Programs across campuses.

The Entrance Examination is a computer based online examination to be held at the **test centers**. It is categorized into four different categories namely:

- NMIMS-NPAT
- NMIMS-CET
- NMIMS-MST
- NMIMS-LAT

Before registering, the candidate must make sure they have thoroughly read all of the guidelines.

The Duration of Program is applicable for UG program of School of Commerce (SOC), School of Economics (SOE), Jyoti Dalal School of Liberal Arts (JDSOLA), Nilkamal School of Mathematics, Applied Statistics & Analytics (NSoMASA), School of Branding and Advertising (SOBA) and Pravin Dalal School of Entrepreneurship and Family Business Management (PDSE)

In accordance with NEP 2020 guidelines, NMIMS University has introduced a 4-year duration degree program (UG) from the academic year 2024-2025 with a focus on research / multi-disciplinary focus in the 4th Year. The students successfully completing this program will be offered Honor's degree in their respective disciplines.

Students will be provided with exit option after 3 years. A student pursuing a 3-year degree will not be eligible for Hons. Degree. Students who are interested in pursuing a four-year Hons. Degree have to indicate their preference at the end of the 2nd year of the three-years program.






- **RETAKE/S:** Candidate can attempt maximum 2 RETAKES in any selected category i.e. (1st main test plus 2 retakes). The highest marks among the total attempts will be considered for respective school merit process.
- Once the main exam delivery is done, candidate cannot add new school in the same category for retake, but he / she can add new category of test.
- **Candidate is recommended to schedule exam/s slot at the earliest to avoid last minute disappointment to get a convenient / date preferred optimal slot. There will be a chance, not to get the preferred / optimal slot. NMIMS Management will not be responsible for such arrangements.**
- Strictly NO Rescheduling or cancellation is allowed

Important Instruction for candidates registered for NMIMS – PAT, NMIMS-CET, NMIMS - MST and NMIMS-LAT

Admission process for NPAT, NCET, NLAT and MST for Batch-2026 will be held in **two phases** as per the above schedule mentioned.

- Candidates who have registered for Phase-1 are required at least 1 attempt in Phase-1, or they may also attempt all 03 attempts (that means main + retakes) in Phase-1.
OR
- They can attempt Retake/s (Retake-1 / Retake-2) in Phase-2.
- Merit list will be declared of Phase-1 candidates based on their highest score, and they will have the first opportunity to be admitted before the deadline.
- Merit list for Phase-2 will be prepared which includes Phase-1 candidates also, along with their most recent best score across all attempts. Admission / counseling for Phase-2 will only be granted based on the most recent merit number.

- Phase-1 / Phase-2 seats will be allotted distinctly and sanctioned by NMIMS Management. It will be entirely discretion of NMIMS Management.
- Further details will be available in admission / counseling offer letter.

E-mail confirmation:

- Post scheduling of the examination, the confirmation mail from (pearsonvueconfirmations@pearson.com) will be sent to candidate's registered email ID.
- Candidate will receive separate email from (pearsonvueconfirmations@pearson.com) for each exam scheduled.

Admit Card:

- The admit card is generated after the exam is scheduled. The test center, city, and selected exam date are displayed on the admit card.
- Admit card will be available on the candidate dashboard. Kindly download the admit card by logging to your dashboard.

Test Center:

- Candidate needs to show the Admit card (hard copy) as a primary ID proof and any document from listed below as a secondary id proof (hard Copy) to the Test center staff.
- The verification staff at the test center will compare the photograph on the admit card with the person appearing for the examination. Therefore, candidate is requested to upload their recent photograph to avoid any confusion at the test center.

List of ID proof that candidate can carry to the test center are as below:

- Voters ID / Passport / Aadhaar Card / PAN Card / Driving License (Learner license will not be accepted) / 12th Board Admit Card with photo
- The name on the original Government ID must exactly match with the name mentioned on the Admit Card
- Candidate shall be allowed to attend computer-based test only on the scheduled date/ time.
- Candidates should reach the test center at least 30 minutes before the scheduled time of exam.

Provision for Physically Challenged Candidates:

- The candidate must upload their Disability Certificate at the time of online registration. The medical certificate of any Government authorized hospital would be accepted. For the Mumbai campus, Medical Certificate from Sion hospital / Nair hospital would be only accepted.
- This will be reviewed and approved by the NMIMS authority.
- Post the approval, the candidate shall get email on their registered email ID. Further he / she can make the payment and schedule the examination.
- Appropriate assistance will be made available at the test center.

- Cancellation of registration is not allowed at any point of process.
- Registration Fees is **NON-REFUNDABLE / NON-TRANSFERABLE**.
- Request to change the exam category or add Schools in the same category after the exam will not be entertained.

Important Instructions with regards to Application and scheduling examination: -

- The name on the Aadhaar card and NMIMS registration / admission form should be identical.
- Keep AAPAR ID / ABC ID “(Academic Bank of Credits)” details ready before filling the registration form. (Please visit website for creating ID : <https://abcdcard.co.in/>)

- Candidate can register only once for each category. Duplicate registration from same candidate will be rejected, even if exam is taken. Both registrations will be annulled and fully discretion by NMIMS, at any stage of admission process.
- Test center and date has to be chosen by the candidate only. Once chosen it cannot be changed at any reason.
- Candidate will have to report for exam on the scheduled date and time only. Rescheduling or cancellation of exam / registration is not allowed.

Eligibility: Candidates appearing for their final 10+2 or equivalent examination can also apply for test. It is the sole responsibility of the candidate to check his / her eligibility before applying for any course.

If a candidate is found ineligible even after commencement of the program, he / she would be discontinued from the program and fees will be paid in accordance with standard procedure.

Candidates should meet the following requirements in addition to the eligibility requirements listed above:

- Candidates **Diploma awarded** from International Baccalaureate (IB) Board will be considered equivalent to 10+2 examination providing they have confirmed 24 grades/credits compulsory and have passed 3 subjects at Higher Level (HL) and 3 subjects at Standard Level (SL) plus extended essay and Theory of Knowledge (TOK).
- Candidates **Diploma Programme (DP course) awarded** from International Baccalaureate (IB) Board will be considered equivalent to 10 +2 examination with 2 subjects at Higher Level (HL) and 2 subjects at Standard Level (SL) OR 3 subjects at Standard Level (SL) and 1 subject at Higher Level (HL)
- **a. IBCP equivalence for General Strand (Arts, Commerce, Science, Law):** Candidates Career related Programme (CP) course awarded from International Baccalaureate (IB) Board

will be considered 2 DP subjects with at least 1 subject at Higher Level (HL) and minimum 3 points in each DP subject.

Additionally, it is necessary to complete at least 03 Career Related Studies (CSR) courses given by IB-approved partners, such as the World Academy of Career Program.

b. IBCP equivalence for Engineering or Medicine Strand: Candidates Career related Programme (CP) course awarded from International Baccalaureate (IB) Board will be considered 3 DP subjects (Maths, Physics, Chemistry, Biology or other similar subjects) with at least 1 subjects at Higher Level (HL) and minimum 03 points in each DP subject.

Additionally, it is necessary to complete at least 03 Career Related Studies (CSR) courses given by IB-approved partners, such as the World Academy of Career Program.

Addition qualifying requirements as specified by statutory agencies such as AICTE and PCI in accordance with program requirements.

- In the online registration or e-admission form (if selected) for the 10+2 or equivalent exam, candidates who have passed through any examining board (such as the State Board, CBSE, ICSE, etc.) should indicate the aggregate scores of all the subjects they have taken, opted for, and for which appeared for (not the best of four, five, six, or seven subjects).

The aggregate percentage of all subjects the candidate has opted and appeared will be taken into consideration for confirming eligibility of the candidate for the program at the time of admission.

For A Level Examination (Cambridge Board) with minimum 3 subjects at advance level will be taken into consideration for calculation of aggregate percentage. Ungraded subjects/grades will not be taken into account.

- The candidate shall have passed all the subjects opted and must have appeared in the applicable examination/s in a single attempt.
- Candidate will not be eligible if any subject is marked as ungraded / fail in the mark sheet / grade sheet even if the relevant examining board declares the candidate passed. (except Cambridge Board).
- In case the mark sheet issued by any examining board reflects scores in percentile(s), point system, GPA/CGPA, or performance bands, candidates must provide the equivalent aggregate percentage. For IB board students, an official Indian conversion transcript is mandatory. If a Grade Point Average (GPA) or Cumulative Grade Point Average (CGPA) is provided, candidates must submit the certified equivalent percentage. Please note that the actual aggregate percentage of all subjects listed on the official grade sheet will be considered for eligibility
- The mandatory subject must be taken and passed in accordance with program eligibility.
- Candidates above 25 years of age can apply for B.A. LLB and BBA LLB programs only under NLAT Exam category. The maximum age requirement for all other programs is 25 years old.
- **IB & Cambridge Candidate:** Candidates who do not have final mark sheet will be given "Provisional Admission" based on predicted scores. Fees will be accepted from such candidate

but their admission will be confirmed on submission of final mark sheet before the commencement of the program, if found eligible. The mark sheet/s / transcript/s issued by Board / University shall only be considered.

- International School/s candidates and those candidates who have completed their (10+2) or equivalent examination/s from overseas school/s / Institute/s / University will have to submit AIU/ certificate of equivalence (mandatory) to confirm their eligibility for the program as equivalent to (10+2) examination/s. This criterion also applies to candidates who have completed open school, distance learning, or correspondence courses.
- Only single mark sheet with all compulsory subjects passed is mandatory, no compartmentalized mark sheet will be considered. (Except Cambridge Board)
- Candidate whose final mark sheet is not available at the time of admission is required to upload internet copy / Digi Locker copy of result within 07 working days of the announcement of the final examination result to confirm the program eligibility. The candidate's admission will be revoked, if they fail to present the mandatory document within the specified timeline.
- Candidates who have cleared their 10 + 2 (12th Standard) by doing a part time course or through distance learning, correspondence course externally, open school from a recognized University are eligible to apply & register as per UGC guidelines.
- **If at any stage of the program it is found that a candidate does not meet the eligibility criteria or has furnished incorrect information in the application form, his/her admission to the course, even if already admitted, will stand cancelled. Fees will be refunded as per the applicable refund rule clause. If the candidate does not voluntarily withdraw, the University will proceed with cancellation of admission.**
- The admission information handout's eligibility requirements will serve as the only document for program eligibility. School's brochure or prospectus or any other promotional material will only be used as a guide and not be used to refer eligibility.
- The payment of fees does not confirm fulfilment of the admission eligibility criteria. Admission will be granted only after verification of all required documents and compliance with the prescribed eligibility norms.

Selection Process:

- Merit list will be prepared based on the performance of the candidate in NMIMS-NPAT / NMIMS-CET / NMIMS- MST / NMIMS – LAT exam.
- The decision regarding the cut-off of the merit list will solely lie with SVKM's NMIMS.

Note:

- Candidate will not be considered for merit list if they fail to update the correct information in the online registration form.
- It is the sole responsibility of the candidate to ensure that correct marks are entered.

- At any given point of time, if it is found that the information given by candidate i.e 12th or equivalent exam is incorrect, the candidate admission will be cancelled and fees will be refunded as per prescribed refund rules.
- **For Engineering:** Candidates will be called for Counselling as per their merit. In the counseling session, candidates will be given admission to various specialization as per their merit, choice and availability of specialization as per eligibility criteria.

Hostel Facility for Admitted Candidates:

After completing the payment of the admission fee, candidates may apply online for hostel accommodation through NMIMS hostel application portal. Once the hostel application is approved and the candidate receives communication requesting payment of the hostel fee, the payment can be made online.

Hostel accommodation is allotted on a **first-come, first-served basis**.

Please note that hostel accommodation is **compulsory** for students at:

NMIMS Indore Campus (except for students who are residents of Indore)

NMIMS Hyderabad Campus (except for students whose domicile is Jadcherla, Shadnagar, or Mahbubnagar)

NMIMS Bengaluru Campus (except for students who are residents of Bengaluru (with parents only)), Students Residents of Bangalore and not opting hostel accommodation need to provide Address proof (Aadhar Card of student and parents with Bengaluru Residence Address) for verification purpose.

NMIMS Shirpur Campus (Hostel accommodation is compulsory in NMIMS Shirpur Campus, except for students from Shirpur Taluka or residents (with parents only) within 30 km (by road) of NMIMS Shirpur Campus. (Aadhar Card of student and parents will be compulsory).

Refund Rules for all programs / Schools

Refund Rules: As per the notification of UGC.

Important Instructions after merit list:

- For cancellation / withdrawal of admission: Withdrawal /cancellation means voluntary withdrawal / cancellation by candidate for any reason. Candidate should visit <https://upload.nmims.edu/admission/cancellation/>
- Canvassing in any form for admission will disqualify the candidature.
- If at any stage, it is found that a candidate does not satisfy the eligibility criteria or the information furnished by him/her in the application form is incorrect, his/her admission to the

course, even if selected, will stand cancelled and fees shall be refunded as per refund rule clauses.

- It is the sole responsibility of the candidates to ascertain whether they possess the necessary and requisite qualification for the admission to the courses at NMIMS.
- NMIMS will start program only if 20 candidates have taken admission. If 20 candidates do not take admission the tuition fees of students who have taken admission for the program shall be refunded. Alternately students shall be offered admission to other programs based on seat availability.
- All matters of dispute will be subject to the legal jurisdiction of Mumbai only.
- The candidate must have appeared for all his subject(s) / exams before the commencement of the respective program (s) of NMIMS (Deemed to be University). The examination of none of the subjects should be held after the commencement of the respective course.
