- Dr. Ashwini presented the syllabus of BTI Semester VI. For the course of "Introduction to Operating Systems", Dr. Kumar raised a concern that contents of few units match with the syllabus of "Operating Systems" that the students have in their higher semesters. It was hence suggested that syllabus be revised and oriented more towards Linux as an Operating System so that lab exercises can then be framed accordingly.
- For the course of Introduction to Database Systems, it was suggested that the content in the unit "Relational Database Design" and "Relational Algebra" be reduced and more content on SQL queries to be added.
- Dr. Ashwini discussed the changes in the course structure, which was only due to the replacement of the course "Introduction to Cybersecurity and AIML" by "Introduction to Soft Computing Techniques". It was pointed out by Chairperson, Board of Studies that the course had content of two different courses & so as discussed, it was replaced by "Introduction to Soft Computing Techniques" which is an important introductory course.
- Dr. Kumar suggested that the unit on Neural Networks can be removed from the syllabus of "Introduction to Soft Computing Techniques". It was discussed that more hours can be given to the unit on "Introduction to Machine learning", by including types of ML (Supervised & Unsupervised) and also few applications of ML.

Action taken: The above suggested changes are incorporated in the revised syllabus.
