1. Introduction:

Important:

- Vacant seats will be calculated after NMIMS students' internal transfer to MBA Tech. and B.Tech. Program **PLUS** 10% of the sanctioned intake of the first year.
- Further admissions will be done by counseling.
- A detailed schedule will be displayed separately in the counselling offer letter.
- Existing NMIMS / MPSTME / STME candidates cannot apply for this process/campus transfer.
- No appearing candidate will be allowed to attend the counselling process.

3. Eligibility Criteria:

It is the sole responsibility of the candidate to check his/her eligibility before applying for the course.

MBA Tech.

- Candidates passing Diploma with a minimum 75% (aggregate score as mentioned in the final marksheet) or equivalent at Diploma. Candidates passing the First Year of B. Tech. / B.E. with CGPA ≥ 3.00 out of 4.00 or equivalent marks (aggregate) and no Backlog of the First year.

B.Tech.

- Candidates passing Diploma with a minimum 60% (aggregate score as mentioned in the final marksheet)
- Candidates passing the First Year of B. Tech. / B.E. with CGPA ≥ 3.00 out of 4.00 or equivalent marks (aggregate) and no Backlog of the First year.
- **For Second Year MBA Tech / B. Tech. seats, Diploma candidates will be given preference. If any seats remain vacant thereafter, candidates passing the first year of B.Tech. will be considered.**
- Candidates are required to mention the aggregate percentage given in the final year marksheet for Diploma candidates & the CGPA / aggregate Percentage given in the first year mark sheet for First year Engineering candidates in the online registration form.
- **Candidate will not be considered for the merit list if they fail to mention/update the same in the online registration form, or their result is not available during this period.**
- Candidates awaiting results are not eligible to apply.
- Submission of an AIU equivalence certificate to confirm the eligibility for the program is mandatory for those candidates who have completed their Under-Graduation from overseas boards/ Universities.
- It is the sole responsibility of the candidate to ensure that the correct marks are entered.
- At any given point in time, if it is found that the information given by the candidate, i.e., 10th, Diploma / First year Degree Exam Score, is incorrect, the candidate's admission will be cancelled, and fees will be refunded as per the NMIMS refund policy.
- Candidates above 25 years of age are not eligible to apply.
- Diploma holders of any stream will be eligible for any stream of Engineering and Technology.
- Candidates - whose final marksheet of the qualified examination is not available at the time of their provisional admission, are required to submit their final marksheet copy as soon as the result is declared. In such a case, if the candidate fails to meet the required eligibility criteria, then his admission will be cancelled, and the fees will be refunded as per NMIMS refund rules (even after course commencement).

- The Diploma / First Year Degree (Qualified) examination should have been conducted before the course commencement date.
- Internal / Stream Transfer will not be entertained for any reason.
- Kindly keep ABC ID (Academic Bank of Credits) details ready before filling the registration form (Please visit the website for creating ID_ <https://abcdcard.co.in/>)
- The admission information handout's eligibility requirements will serve as the only document for program eligibility. The school's brochure or prospectus will only be used as a guide and not be used to refer to eligibility.
- Candidate's documents will be verified at the time of the admission process (if selected) & if found not eligible, admission will not be granted in the counseling.

4. **Admission process:**

Online Registration & Payment of fees:

- Visit www.nmims.edu for online registration.
- Online Registration Fee of Rs. 2,000/- plus applicable taxes. Registration Fee is **non-refundable / non-transferable**.
- The Candidates may be called for a counseling session at the Mumbai campus, based on the merit list. Candidates are required to attend the admission process in person for the counseling session. Candidates should carry the Demand draft / Pay order for the eligible course fees. The payment details will be mentioned in the counseling call letter.
- In the counseling session, candidates will be given admission to various disciplines as per their merit, choice, and availability of discipline as per eligibility criteria & vacancy.

5. **Selection Process:**

- Merit list will be prepared based on the performance of the candidate in Diploma (if the candidate applied through the Diploma passed category) / 1st year Engineering examination (if the candidate applied through the First year B Tech passed category).
- The decision of the institute will be final in this regard, and no inquiries or correspondence in this regard will be entertained

Merit Tie: Determination of merit in case of a Tie: If two or more candidates secure an equal number of marks in Diploma / 1st year engineering, their relative merit will be decided based on the candidate securing a higher aggregate Percentage marks in the 10th examination.

8. **Important Instructions:**

- Candidates once admitted in a particular program/Specialization/campus will not be upgraded to another program/specialization & Campus
- Please check the eligibility criteria before applying for the course.
- Candidates are required to attend the admission process in person.
- Candidate's documents will be verified at the time of the admission process (if selected) & if found not eligible, admission will not be granted in the counseling.
- **For cancellation/withdrawal of admission:** Withdrawal/cancellation means voluntary withdrawal/cancellation by the candidate for any reason. Candidate has to upload cancellation form duly filled and signed, fees paid receipt copy & cancelled cheque (personal account) to the mentioned link: <https://upload.nmims.edu/admission/cancellation/>
- Admission to the program is considered as “**Provisional Admission**” till all required and mandatory documents are submitted by the candidate and the same is verified and approved. If it is found that the candidate is not eligible at any stage (even after the course commencement), admission will be cancelled, and fees will be refunded as per the refund rule clauses, even if selected/ admitted to the program.
- If at any stage, it is found that a candidate does not satisfy the eligibility criteria or the information furnished by him/her is incorrect, than application for the admission to the Program, even if selected and fees paid, will stand cancelled and fees will be refunded as per the NMIMS refund policy.
- NMIMS has full right to disqualify a candidate at any stage of the admission process if found ineligible.
